



ILEC Residential Digital Cable TV, High Speed Internet and Telephone Agreement

The following Agreement between Wood County Telephone Company, a corporation organized under Wisconsin law, d/b/a Solarus located at P.O. Box 8045, Wisconsin Rapids, WI 54495 (hereafter referred to as "we", "us" and "our") and its customer, _____, (hereafter collectively referred to as "you" and "your") describes the mutual agreement under which we provide services as described in this Agreement ("Service") to you. You and we are each a "Party" and collectively referred to as "Parties."

The initial term of this Agreement shall be 1 year from the Effective Date. After the expiration of the initial term, this Agreement shall automatically renew on the anniversary of the Effective Date on a month-to-month basis, at the month-to-month rate current at the time of renewal, unless either of us provides the other with one month written notice prior to such anniversary that it intends to terminate the Agreement effective on the anniversary date.

Your continuing use of the Service after any changes to the terms of Service constitutes your acceptance of those changed Service terms. However, if you object to any material change to the non-price terms of Service, you may terminate the Service without termination fee by giving us written notice before the effective date of the material change. You will remain obligated to pay us for Service through the date of termination.

Except as otherwise provided above, if you terminate this Agreement, or we terminate this Agreement because you violate this Agreement, before the expiration of the initial term, you will be assessed a one-time fee of \$25.00 for each month remaining in the initial term, payable upon termination of this Agreement. You and we agree to the terms and conditions of this Agreement, including the End User Master Services Agreement ("MSA"), E911 Terms, Terms & Conditions, Privacy Policy, Acceptable Use Terms, Enhanced Service Agreement, and other applicable policies which are posted on the Solarus website at www.solarus.net which you acknowledge and agree that you have read. Activation & Installation Fee is nonrefundable.

This Agreement shall become effective on the later of the date you sign this Agreement, on the first date on which we make any Service available for your use, or the expiration date of your current agreement with us.
